PURPOSE/ACTION REQUESTED

Consider approving the bids for electric installation of materials from Castrejon Inc. for the Highway 112 Distribution Improvements project.

SUMMARY

On January 27, 2020, City Council approved DGR Enginnering for professional services for relocation and improvement of electric utilities in the CSAH 22 project. A material furnishing contract was approved at the July 13th, 2020 City Council meeting for \$333,350.24. The installation bid package was posted and the City received no bids at bid closing. Following legal counsel advice, DGR then sent out a request for quotes for the installation of electrical materials. The quotes were due on August 26th, 2020 at 1:30 PM. We received four (4) quotes. See attached recommendation letter from DGR. The low quote was received from Castrejon Inc. in the amount of \$336,546.00.
