# ECONOMIC DEVELOPMENT AUTHORITY Meeting Minutes Tuesday, December 27, 2022, 5:15 P.M.

A regular meeting of the Economic Development Authority (EDA) was held on Tuesday, December 27th, 2022, at 5:15 p.m.

#### Item 1 Call to Order

Meeting called to order by Chair Wenisch at 5:15 pm.

# Item 2 Approval of Agenda

**Motion** by Member Sullivan, seconded by Member Williams, to approve the agenda as written. Members Voting in favor: Wenisch, Williams, Sullivan. Members Voting no: None. Motion carried.

#### Item 3 Approval of Minutes - October 31st, 2022

**Motion** by Member Williams, seconded by Member Sullivan, approving the minutes of the November 28th, 2022 Regular EDA meeting. Members Voting in favor: Wenisch, Williams, Sullivan. Members Voting no: None. Motion carried.

#### <u>Item 4 Disbursements Through December 27th, 2022</u>

No Disbursements were made in the month of December.

#### <u>Item 5.a. Brad Bass Presentation on Hwy 169 Acreage</u>

Brad Bass presented to the board his idea for the land off of hwy 169. Essentially, Brad would like to create a road course for car enthusiasts and car clubs to visit and drive around on. This proposed course could also serve as a training area for truck drivers and first time car enthusiasts on the course. This course is **not** meant for racing or spectator events. This road course would operate similarly to what a golf course would operate as, there would be a clubhouse, garages, set times that people can be out on the course (roughly 15-20 people at a time). This would be a seasonal operation from about April to October and the day to day hours are roughly from 9am to 4pm. The EDA is waiting on Brad to put together a more

comprehensive plan that will entail renderings and drawings for the land as well as a business plan.

#### Item 5.b. CEDA Staff Report

#### I: Facade Improvement Applications

Zach Bubany presented the proposed facade improvement application from the Canopy Group regarding the installation of new awnings over the entrances and windows, along with painting and some other miscellaneous improvements. The board approved the application of up to \$5,000 so long as the improvements that are paid for have not already incurred costs such as the painting. The payments must be used for new costs from the proposed application. Zach Bubany also mentioned that he is still waiting on the renderings from Edward Jones so there has not been a signing for that application as of yet.

Member Sullivan motioned to approve the Canopy Group's application of up to \$5,000 of funding from the EDA, member Williams seconded the motion. Members voting in favor of the motion: Wenisch, Williams, Sullivan. Member voting no: none. Motion carried.

# II: 2023 EDA Priority Plan

Zach Bubany presented the 2023 priority plan for the EDA. The three main focus areas are to sell the EDA land off of hwy 169, currently three interested parties in buying the land. The second focus area was to develop housing in the area which would largely stem from the selling of the land off of hwy 169 and using those funds to develop lots. The school property would also play a role in future development for housing seeing as the City will most likely take that land over in the near future. Housing rehabilitation programs are also largely important to pursue to improve the quality of housing stock. The 3rd focus area is making sure to promote business growth and business assistance programs in the community and simultaneously building relationships with parallel initiatives.

#### **III: Housing Update**

Zach Bubany mentioned the existence of housing rehabilitation programs from the SCDP and other organizations that he plans to pursue in the future. There have not been any submissions from the housing RFP that was submitted back in November but there are multiple parties that have shown interest in submitting.

#### **Item 6 Other Business**

Joe Roby presented the monthly financial report to the board. No major changes or noteworthy items for discussion or concern.
