Fire Chief's Report

Chief Wenisch and Asst. Chief Meyer gave an update of Fire Department operations, including:

- YTD calls at 36: lower than 2022 pace, on track with 2021 pace. Noted fewer lift assist calls from Ridgeview Ambulance.
- Discussion of future capital needs, including replacement of 1998 Grass Rig (estimated cost of \$ 240,000). City Council will determine final 2024 capital purchases, considering influx of Public Safety one-time funding from State of MN.
- Two 2022 hires have completed certification, will finalize EMR training in Fall 2023.
- Several grants being pursued for capital purchases.
